first amendment to the united states constitution wikipedia - the first amendment amendment i to the united states constitution prevents the government from making laws which respect an establishment of religion prohibit the free exercise of religion or abridge the freedom of speech the freedom of the press the right to peaceably assemble or the right to petition the government for redress of grievances, **first amendment contents supreme court interpretations** -
